TERMS of Use

EFFECTIVE: October 1, 2018

THESE TERMS OF Site ("TERMS") CONSTITUTE A CONTRACT BETWEEN YOU AND Office Practicum AND GOVERN THE USE OF AND ACCESS TO products and Sites available through the Ideas Portal, website, forums, or other web- or cloud-based sites offered by Office Practicum ("Site(s)").

By accessing or using a Site, or authorizing or permitting another person or entity on your behalf to access or use the Site ("End User"), You agree to be bound by these Terms.
